The Embassy of the Hashemite Kingdom of Jordan presents its compliments to the Ministry of Foreign Affairs of the Republic of Turkey and with reference to the meeting between H.E. Ambassador Ismail Rifaie, and H.E. Bülent Tüfenkci Minister of Trade and Customs of the Republic of Turkey on 6/3/2018 the Embassy would like to provide the following information upon the request of H.E. Minister Tüfenkci during the meeting.

With regards to the incentives given by Egyptian Authorities to ships transiting the Suez Canal and destined to the Port of Aqaba, The Suez Canal Authority agreed to renew the agreement where a 50% reduction of the Canal transit fees is provided to dry bulk ships, cruise ships and container ships servicing the Port of Aqaba. The reduction is applied to all ships servicing the Port of Aqaba and not only ships flying the Jordanian flag. In addition, there may be other incentives given to the ships of Arab Bridge Maritime Company within certain and mutual agreements between Jordan and Egypt, but such information can be obtained from the company itself.

With regard to the capacity of the Port of Aqaba we have the honour to attach herewith the Table of the annual capacity of the Port.

The Embassy would appreciate the esteemed Ministry's assistance in forwarding the above mentioned information to the Ministry of Trade and Customs of the Republic of Turkey.

The Embassy of the Hashemite Kingdom of Jordan avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Republic of Turkey the assurances of its highest consideration.
